1. The followings must be inscribed on the envelope containing quotations:

- 2. Rate should be quoted as per the Table (Annexure-I).
- 3. Validity of the rates quoted should be at least 2 months.
- 4. All taxes, packing and forwarding charges and other charges (if any) should be clearly shown. In absence of specific mention regarding taxes applicable, it will be presumed that the rates are inclusive of all taxes on F.O.R NIT Mizoram, Aizawl basis.

The Institute cannot furnish C or D Forms but can issue Way Bill for onward transportation within the jurisdiction of the State of Mizoram for supply of scientific goods for educational institution.
