NOTIFICATION

Consonant to the approval of the Senate in its 11th Meeting - by Circulation vide **SNT 11.2 dated 22.04.2020** and on the recommendations of the Dean (Academic) and all Head of Departments, it is hereby notified that NIT Mizoram shall execute the concept of Online Mid-Semester Examination for the Final Year UG Students, NIT Mizoram as under mentioned:-

1. Instead of the regular Mid-Semester Examination of 30 marks, for 1½ hours, an Online Mid-Semester Examination of 15 marks shall be held for Final Year UG Students, for **one hour**. Rest of the 15 marks shall be based on assignments.
2. As some courses in UG Final Year are also opted for First Year PG, the Online Mid-Semester Examination is to be adopted for those First Year PG courses too.
3. Subsequently, depending on the feedback of the Online Mid-Semester Examination System for Final Year UG and PG Courses, it may be extended for other Batches too.

MEMORANDUM

SNT 11.3: Proposal on different Academic measures for the students of NIT Mizoram.

Background:

In this period of lockdown due to COVID-19 pandemic, the date of opening of the Institute is not certain. The fourth phase of lockdown period is till 31st May 2020. The interstate travel has not been regularized to pre lockdown condition.

For the interest of the students, the concept of online mid semester examination for the final year UG students was approved by SNT 11.2 by circulation. Online mid semester examinations was conducted for final year UG as well as other students. During the online examinations, connectivity and other issues were faced by the students and the coordinators. For the interest of the students and in continuation to the various measures taken by different Academic Institutes in the country, following academic measures are proposed for NIT MIZORAM as discussed by Director with members of Senate, HoDs and Deans:

1. For all theory courses, the End Semester Examination shall be based on assignment or project based question (if feasible) of 30 marks followed by Viva of 20 marks.

2. For practical courses of final year UG, the End Semester Evaluation shall be on the discretion of the course coordinator and the respective HoDs.

3. Practical Courses and the Evaluation of other years' UG and PG shall be conducted after the physical reporting of the students in the coming semesters.

4. Evaluation of B.Tech and M.Tech projects shall be done using PPT and Viva. Soft copy of the presentation has to be submitted by the students.

5. For Final Year UG and PG students, all the Evaluation process should be completed and the Results to be submitted by course coordinators to Faculty In-charge Examinations, with a copy to Dean (Acad) **within 30th June 2020.**

6. For other years' UG, PG and PhD students, all the evaluation process should be completed and the results to be submitted by Course Coordinators to FIC Examinations with a copy to Dean (Acad) **within 7th July 2020**.

7. As per UG Academic Regulations, the First Year UG students are provided a chance to change their branch based on the CGPA and minimum criteria after the Second Semester. Due to COVID-19 pandemic in the Second Semester, practical courses could not be held. Hence following relaxations in minimum criteria may be allowed:-

a) CGPA \geq 8.0 (No relaxation)

b) Earned credit at the end of Second Semester without Second Semester practical courses = 35.5 (Total credit after 2nd Semester is 42)

8. Depending on the situation, the Chairman, Senate may be authorized to take additional measures, as deemed fit, for the academic interest of the students in the present semester.
