MINUTES OF THE 14th DEANS' COMMITTEE dated 20.06.2022


Attendance is at Annexure – I

- Theft/loss of Workstation allotted to Dr. Vinay Singh be taken up through submission of FIR.
- With the cases of breach in security, Dean (SW) is required to provide extra security measures in liaison with the Security FIC and Security Supervisors. Contact details of Security Supervisors is to be prominently displayed in all facilities.

- As already decided by the 6th Deans Committee dated 25.04.2022, 'In-House' ERP is to be taken up and completed before 01.08.2022.

Action: Assoc. Dean (SW)/FIC T&P

- Hostels to be readied by 25.07.2022 for the current students. Wardens are to provide concerted action.
Action: Dean (SW)/Assoc. Dean (SW)
- In order to maintain quality standard, PhD Thesis Examiners will be as: 4 Indian and 4 Foreign Reviewers with good global standing.
- As the MoU with IIT Madras is being finalised, the Top 11 B.Tech students need to be geared for their Final Year in IIT Madras.
- Integrated Programmes under the Departments of Physics, Chemistry, Economics, Mathematics and Computing, shall be initiated from the Academic Year 2023-24 along with B.Tech Architecture and M.Tech Civil Engineering.
