	<p>As per the application received from CSE department with the CSE performance evaluation sheet, the M.Tech student Miss Megha K bearing Roll No. MT20CS004 was admitted through Internal Entrance Examination in the OC category based on her marks as per the approved format from the selected list. But the student belongs to SC category and does not qualify for OC on the basis of her B.Tech. CGPA (6.46) where minimum CGPA for OC is 6.5. Her selection in the OC category was an error due to oversighting. After the CCMT 2020 admission was completed the Department found that they do not have SC category seat. the Director was informed who constituted the Deans' Committee with the HOD (CSE) as Convener to examine the matter and find a solution to the issue. 	<p>As decided by the 12th Senate held on 24.07.2019 under SNT 12.10 for Online Academic Classes during Academic Year 2020-21 (Odd Semester) and the interests of the students, the online classes have been started for UG 2nd Year to 4th Year and the Ph.D course work. The ground realities at Aizawl, Mizoram are not favourable to conduct physical mode examinations. Hence, the End Semester Examinations of UG 2nd, 3rd, and 4th year may be approved to be conducted as per the decision of SNT 11.3 from 30.11.2020 (in original, it is scheduled on 18th November, 2020 as per the Academic Calendar of 2020-21 Odd-Semester).</p> <ol style="list-style-type: none"> 1. For all Theory Courses, the End Semester Examination shall be based on assignment or project based question (if feasible) of 30 marks followed by Viva of 20 marks. 2. For Practical Courses, the End Semester Evaluation shall be as per the discretion of the Course Coordinator and the respective HoDs. 3. Evaluation of B.Tech and M.Tech projects shall be done using PPT and Viva. Soft copy of the presentation has to be submitted by the students to the HoDs. <p>For M.Tech First year (CSE, ME, ECE, EEE) and Ph.D Course Work, the Online Mid-Semester Examinations may be approved as per the decision of SNT 11.2.</p> <ol style="list-style-type: none"> 1. Instead of regular Mid-Semester Examination of 30 marks for 1 ½ hours, an online Mid-Semester Examination of 15 marks shall be held for Final Year UG students for one-hour. Rest of the 15 marks shall be based on assignments. <p>The Course Coordinator shall preserve the documentation of the implementation of the plan of evaluation for respective courses.</p>
