As per Schedule-3 (Current Liabilities), there was unutilized grant of about Rs.38 crore as on 31.3.2021. Interest earned on the unutilized grants, may be refunded to the Ministry." 

Position of the 5 Years Contractual Faculty:

The services of the 5 Assistant Professors on 5 Years Contract viz. Mr. Suman Majumder , Mrs. Krishnarti De, Mr. Sandeep Kumar Dash, Mr. Ramesh Kumar & Mr. Anagha Bhattacharya was extended for the 3rd time by the 24th BoG meeting on 19.01.2021 as above. As per the decision of the Board, extension was considered for 6 months ending on 30.06.2021, during which period they are expected to obtain their Ph.D degrees. The total years extended beyond the contract period of 5 years is 2 $^{1/2}$ years.

Now that the period is concluding, the Institute's Committee on its meeting on Dt.23.06.2021 reviewed their respective status as to completion of their Ph.D degrees, as undermentioned: Copy of Minutes of the Meeting is placed at Annexure - V of BoG 27.3.

For Sl. No. 1-3, progress made is satisfactory, given that they were enabled to wind up their Ph.Ds within the extended period, i.e. within 7½ years.

For Sl. No. 4, since the faculty has already submitted his thesis, the report from NIT Silchar is awaited and is anticipated that could materialize within 3 months. Therefore, Mr. Ramesh Kumar's service may need to be extended for 3 months to complete

his Ph.D. i.e. upto 30.09.2021, on humanitarian grounds.

For Sl. No. 5, it is learnt that Mr. Anagha Bhattacharya has made progress in his research but has yet failed to submit his thesis within 7 ½ years extended period. The Institute has therefore, sought the progress report, attendance & duration required for thesis submission from Mr. A. Bhattacharya's supervisors at Jadavpur University. The report from his Supervisor has been received through email and copy of the Supervisor's Report and Recommendation is placed at Annexure - VI of BoG 27.3

As understood from their Supervisors from NIT Silchar and Jadavpur University, Mr. Ramesh Kumar requires additional 3 months and Mr. Anagha Bhattacharya requires additional 8 months, beyond 30.06.2021 i.e upto 30.09.2021 and 28.02.2022 respectively, for completion of their Ph.Ds.

On close introspection of the decision of the 24th BoG, it is indicative that further extension of service for Mr. Ramesh Kumar and Mr. Anagha Bhattacharya is no longer viable.

It may however be highlighted that Mr. Ramesh Kumar is on the verge of completing his Ph.D while Mr. Anagha Bhattacharya yet requires 6-8 months more, therefore, it is pertinent to mention that the additional extension of service ensure their service regularization, in the near future.

Though the services of Mr. Ramesh Kumar and Mr. Anagha Bhattacharya are yet maintained in the Institute beyond 30.06.2021, till date, the question of payment of their Pay and Allowances for the month of July, 2021, further requires the explicit decision of the BOG, NIT Mizoram.

With the month of July, 2021 due for closure and with the said teachers i.e Mr. Ramesh Kumar and Mr. Anagha Bhattacharya having rendered their services for the said month, payment of their Pay and Allowances for July, 2021 is a liability; as non-payment could attract as infringement on the fundamental rights of the said teaching Faculties.

Given the aforesaid, the pay & allowances of July, 2021 maybe released to them.

But, given the critical juncture that the said teachers stand in & the possible overture that could face them (of their services not being extended by the BoG), the said teachers have been informed to willingly sign an Undertaking(s) - that the disbursal of Pay & Allowances for July 2021 is subject to the decision of the BoG & in the event of the BoG decision negating their extension, they would be required to refund the said payment, in full, within 10 days' time.

The Board may therefore deliberate on the services of Mr. Ramesh



Kumar and Mr. Anagha Bhattacharya, Assistant Professors on 5 years contract, Dept of Electrical & Electronic Engg, NIT Mizoram for additional **3 months in case of Mr. Ramesh Kumar** w.e.f. 01.07.2021 – 30.09.2021 & for additional **8 months in case of Mr. Anagha Bhattacharya** w.e.f 01.07.2021 – 28.02.2022 from the date of expiry of their third extension, respectively.

After detailed deliberation, the Board decided to permit extension of the contract services of Mr. Ramesh Kumar, Assistant Professor, EEE Dept, for an additional 2 (two) months w.e.f. 01.07.2021 – 31.08.2021 and Mr. Anagha Bhattacharya, Assistant Professor, EEE Dept, for an additional 4 (four) months, w.e.f. 01.07.2021 – 31.10.2021.

The extension of the contractual services, is, however, granted with the condition that further extensions will no longer be feasible and that the aforesaid extended periods of service shall be the last and final extension.

The Director (Temporary Charge) shall relieve Mr. Anagha Bhattacharya, Assistant Professor, EEE Dept from any administrative responsibilities, if any, with immediate effect so as to facilitate his Ph.D works.

The Board of Governors further decided that if the Ph.D thesis submission is not completed by Mr. Anagha Bhattacharya as on the extended dateline, i.e. 31.10.2021, the Director (Temporary Charge) shall suo moto terminate the services of the aforesaid faculty member.
