## MINUTES OF THE 4<sup>th</sup> DEANS' COMMITTEE dated 11.04.2022

- > Welcome address by Prof. S. Sundar, Director, NIT Mizoram.
  - The Director highlighted on the need to improve and to revamp the system of NIT Mizoram based on the recent inspection rounds of the Academic Departments made by him and that appropriate measures for improvement are to be taken up by all faculty despite the limitations.
  - The Director appraised the final closure of MAL 1101 with results of the affected students declared smoothly.
  - The MoU to consign outstanding students to IIT Madras for B.Tech Final Year is in the pipeline and is being finalised by the Director with IIT Madras.
  - Direct recruitment and movement to higher AGP of internal faculty matters will be taken up soon through mission mode.
  - The functioning and maintenance of Health Care Centre is appreciated and expansion may be envisioned.
  - All Academic Departments to ready themselves for offline classes from 01.08.2022 as per the State Govt. latest SOPs.
  - The Registrar informed on the disposal of the National Green Tribunal case and that final approval for Forest Clearance is waited. It is hopeful that construction of buildings in the permanent campus can be initiated soon pending Forest Clearance.
  - Deans and HoDs to be accessible and approachable at all times.

- Institute to work towards internal quality assessment.
- Classrooms and other facilities to be upgraded.
- The Registrar informed that the UGC-JRF Fellowship issues of K. Santha Ram, Research Scholar, Registration No. DH20HS009, BS&HSS Dept. was/is being attended to in earnest and conveyed that the proposal to provide reimbursable financial assistance from Institute Funds is already in the pipeline if UGC matters are not resolved soon.
- If Compulsory Internship is a part of Course Curriculum, the grades so obtained has to be reflected in the transcripts. No financial commitment will be forthcoming from the Institute.
- The 5<sup>th</sup> Convocation shall be held in hybrid mode during May or June, 2022 with the Chief Minister, Mizoram as the Chief Guest.
