Terms and Conditions for Appointment of Ah-hoc Assistant Professor:

- The appointment will be purely on *Ad-hoc* basis on consolidated remuneration of ₹. 35,000/- (Rupees Thirty Five Thousand only) per month initially for a period of One Year liable to be extended/curtailed at the discretion of the competent authority.
- 2] No other service benefits at par with the regular employees of the Institute will be admissible.
- 3] A contract agreement will have to be signed with the Institute on ₹. 100/- non-judicial stamp paper before joining the post.

- The contract of the person appointed may be terminated by either side with a one month prior written notice to the Institute. The Institute will be at liberty to terminate the contract of the person at any time with immediate effect by paying the contractual remuneration of one month in lieu of one month notice.
- 5] 2½ (Two and half) days Earned Leave will be admissible for each completed month of contract service as per CCS (Leave) Rules.
- The appointed person is required to join the post immediately preferably **on or before 10**th **February, 2014** after getting the offer letter through e-mail/fax.
