Sub: Call for Scholarship Application for the Scheme: National Fellowship and Scholarship for Higher Education for ST Students under the Ministry of Tribal Affairs, GoI for the Academic Year 2019-20 - reg.

It is to inform the Scholarship Aspirant(s) that the Ministry of Tribal Affairs, GoI has initiated the Call for Scholarship Application under the Scheme: National Fellowship and Scholarship for Higher Education for ST Students. The application for the scheme will be made through National Scholarship Portal (NSP). There may be some other schemes by the Ministry of Tribal Affairs, so it is advised that prior to choosing any Scheme, the eligibility criteria for that particular scheme are verified by the Scholarship Aspirant(s). Also, each Scheme has it's own set guidelines for Entitlement, and thus scheme to scheme admissible grant vary.

The relevant information can be found at Ministry of Tribal Affairs website: https://tribal.nic.in/, the General Instruction(s) for student(s) and other associated can be found under the tab: Scholarship/Fellowship -> Top Class Scholarship.

Scholarship Aspirant must note that Ministry of Tribal Affairs does not allow application for multiple Schemes under its ambit. So, it is expected that one must be careful while making the application.

There are two categories of Scholarship Aspirant: FRESH (one who is applying for the First time) and RENEWAL (one who has already received Scholarship in the previous year(s)). The procedure for Scholarship Application remains the same for both the category. For RENEWAL category, a seperate CIRCULAR has already been issued vide NITMZ/E-35/SCHO./2018/707 dtd 4 September 2019.

Scholarship aspirants are informed

- ♦ To fill the Online Application Form through NSP with uploading of the necessary documents in the portal. Instructions are available in the NSP.
- ◆ Once the Application Form is submitted online, they are informed to submit a copy of the [ONLINE] Application Form submitted through NSP along with all the necessary documents (such as Caste Certificate, Income Certificate, Bonafide Certificate, Fees Receipt, Stationery Bill (if applicable, see the guidelines of the Scheme) and Laptop Purchase Bill (if applicable,

see the guidelines of the Scheme) etc.) for Institute Level Verification.

- ♦ While submitting the Application Form, 6 (Six) additional Scholarship Form needs to be enclosed. These forms are available at the 'Scholarship' webpage of the Institute website.
- ♦ It is expected that the Scholarship Application Form is submitted at least 10 days before the dateline of the last date as specified in the Portal for that particular Scheme for Institute Level Verification. Application submitted online and not for Institute Level Verification by the last date [of verification] would be marked as 'Defective'.

Scholarship Aspirant needs to understand the fact that submission of Scholarship Application and subsequent verification at Institute Level doesn't guarantee the award of Scholarship. Institute is just a facilitator to verify the credential of data stated by the Scholarship Aspirant(s) in their Application Form and forward their Application to respective Agency (here Ministry of Tribal Affairs, Gol).

Last Date of Online Application (through NSP): 31 October 2019

Last Date of Institute Level Verification : 5 November 2019

Scholarship Aspirant must note that in case for 'FRESH' application, a MERIT LIST would be prepared by the Ministry of Tribal Affairs, GoI while selection of awardee for the Scheme. The criteria of it will be decided based on number of application received under Scheme and at a later stage after the whole process of application is over. The details of last year (AY 2018-19) can be found in the Circular issued vide NITMZ/E-35/SCHO./2018/439 dtd 1 July 2019.

Sub: Criteria of Selection for Scholarship (FRESH) under "National Fellowship and Scholarship for Higher Education for ST Students" for the year 2018-19 - reg.

This is to notify the criteria of selection for Scholarship under the "National Fellowship and Scholarship for Higher Education for ST Students" (Ministry of Tribal Affairs) for FRESH applicants for the year 2018-19. The Criteria of Selection for the Scholarship are as under:

- (a) Based on the marks obtained in last passed examination.
- (b) On the basis of **level of course** (12th, Graduation and Post-Graduation) and further sub-division into four streams (Engg. & Tech., Humanities and Social Science, Management and Science).
- (c) Stream wise allocation of slots out of total slots of 1000 is on the basis of total number of eligible applicants in each stream as a percentage of total number of verified candidates on pro-rata basis.
- (d) The provisional Merit List is prepared with the approval of competent authority (Ministry of Tribal Affairs) as per Scheme Guidelines based on the marks entered by the student at NSP (National Scholarship Portal).
- (e) Under Engg. & Tech. Stream, minimum / cut off marks is 78.9% in 12th Level of course.
