Vide Rule 18 (1) (ii) of the Central Civil Service (Conduct) Rules, 1964 and as per the direction of the OM No. C-19011/7/2017-Vig dated 6th January, 2021 from the Vigilance Section, Department of Higher Education, Ministry of Education, Govt. of India, this is to circulate to all the regular **Group 'A' and Group 'B'** employees of NIT Mizoram (Teaching Faculty and Non-Teaching) the under mentioned instructions for strict compliance:-

- (i) All regular Employees including faculty of NIT Mizoram, under the administrative jurisdiction of the Min. of Education, Govt. of India, are required to submit their **Immovable Property Return latest by 31st January** of the year to the undersigned. The timely submission of such IP Returns by the employees shall be notified at the Institute's Website.

The IPR will, hereon, be carried on as annual affairs and all regular employees of NIT Mizoram are urged to submit the same during the month of **January every year**. Format of IPR is enclosed at **Annexure - I**.

- (ii) Employee who fail to submit the property return within the prescribed time limit would be denied Vigilance Clearance in terms of DOP&T's O.M No. 11012/11/2007-Estt(A) dated 14.12.2007 read with the OM of even number dated 27.09.2011.
