
**GUIDELINES FOR CENTRAL LIBRARY OPENING HOURS:**

1. The Central Library shall be opened from **9:00 AM** till **8:00 PM** on all working days.
2. The Central Library is restricted for all faculties, staffs and students of NIT Mizoram only.
3. The **Circulation Timing** shall be **9:30 AM** to **5:00 PM** on all working days.
4. Maximum **25 students** shall be permitted in the reading section as the Central Library's reading room can accommodate only 25 students.
5. The Central Library and its premise shall be vacated on **8:00 PM** positively to avoid any sort of distraction to the nearby residents.
6. All other Rules and Regulations of the Central Library shall be strictly enforced.
