#### ORDER

In consonance to the resolution of the 21st Meeting of the Senate, NIT Mizoram, vide SNT: 21.9 dated 14th March, 2023, following revision/addition to the existing B.Tech Regulation are included as under-mentioned:

- (i) Clause No. 8.8 shall be modified as: Department BOS should be conducted within a period of maximum three academic years.
- (ii) Clause No. 12.3 (iii) shall be modified as: A student shall be debarred from an examination if he/she is found to use unfair means or in possession of any unscrupulous thing in the Examination Hall for that subject. He/she will not be allowed to appear in the re-examination of that subject while he/she will appear in the examination for the same subject as a Backlog candidate when the paper will be floated by the concerned department. However, the student may continue to give other exam papers provided he/she does not use any unfair means.
- (iii) Appendix- III Pt. 4. shall be modified as:
  - (a) Each Department shall have a Departmental Disciplinary Committee and Departmental Grievance Committee for the students' fraternity.
- (b) If any misconduct by the student is observed within the academic premises, it is to be reported to the respective HOD. Departmental Disciplinary Committee to take action leading to the class suspension. Based on the severity of the misconduct, it may be forwarded to be Central Disciplinary Committee of the Institute.

#### ORDER

In consonance to the resolution of the 21st Meeting of the Senate, NIT Mizoram, vide SNT: 21.10 dated 14th March, 2023, following revision/addition to the existing PhD Regulation shall be included as under-mentioned:

- i. PhD Regulation Clause 14.1 shall be modified as: After the State-of-the-Art Seminar (Clause 13), a student presents his/her progress seminar annually and that will be monitored by the respective DC. Such presentations are open to all.
- ii. PhD Regulation Clause 2.1 (iv) shall be modified as: Project-Staff: He/ She gets fellowship from the Sponsored Project, works full-time for the Degree and on completion of the Project before the award of the Degree, the category will be changed to Regular Mode with Institute Stipend for the remaining years (total 5 years from date of registration as PhD student) of the PhD based on the availability of Regular position with the concerned Supervisor, otherwise the category changes to Self-Financed Mode. At the time of selection/appointment, the relaxation needs to be stated with clarity. Stipend to be given for a minimum period of 1(one) year.
- iii. PhD Regulation Clause 19.1 (iii) shall be modified as: Full-time Regular and Self-Financed Ph.D scholars who are given extension under special circumstances due to not being able to finish his/her PhD in the 5 year tenure, should be in-station till his/her PhD thesis submission being a Full-Time scholar. Also, the concerned Supervisor will not be given any new candidate in his/her place.
- iv. Full Time Regular PhD student may receive an allowance of Rs. 25,000.00 (maximum) per year in his/her five years tenure to perform sample characterization/fabrication/analysis/field work etc. Related activity on production of purcase or utilization receiptts only with prior approval of the competent authority duly confirmed by the Supervisor. The maximum ceiling will be maintained at Rs. 5 lakhs in an Academic Year and will be provided in first come-first serve basis.
