The appointed persons should note the following:

- i) The appointment is of contract basis. All the appointees will be on probation for a period of 2 years from the date they join their duties. During their service, they will also be eligible to draw an annual increment.
- ii) This appointment is subject to general terms and conditions of service applicable to employees of NIT Mizoram as in force and as amended from time to time by the Government of India.
- iii) They will be required to execute agreement with the Director, NIT Mizoram on ₹. 100/- non-judicial stamp paper before joining.
- iv) The appointees are expected to produce relieving certificate, if applicable at the time of joining.
- v) They should convey their acceptances of this offer immediately and join their duties as soon as possible but definitely on or before **4**th **January**, **2016**.
- vi) They should report to the Director, NIT Mizoram at Chaltlang, Aizawl through Dy. Registrar (F&A), NIT Mizoram for verification of their original certificates and fill in the attestation form and hand it over to the Dy. Registrar (F&A) at the time of joining.

- vii) Upon joining NIT Mizoram, the appointees will have to present themselves for Medical Examination as per the Government of India norms. These appointments are, therefore, **provisional**, subject to the Medical fitness for the respective post, and character and antecedents verification report from Police Authorities.
- viii) Their Caste Certificates will be verified through the proper channel and if the verification reveals that the claim to belong to OBC (non-creamy layer as per the new format)/SC/ST (as applicable) is false and/or their caste certificates are invalid, their service will be terminated forthwith without assigning any further reasons, and without any prejudice to such further action may be taken under the provisions of the Indian Penal Code for production of false certificates.
- ix) They will be governed by New Pension Scheme of the Government of India which is in effect from 2004.
- x) In case if appointee is willing to resign from his/her post at NIT Mizoram at any time, he/she may be released from the Institute only after completion of all the formalities of the on-going semester.
- xi) The appointees may be allowed for reimbursement of relocation allowance subject to the limit of ₹. 50,000/- on joining the post at the Institute on production of original bills.
